

2022 New Harmony *Field to Finish* Art Sales Agreement  
Salon Copy (to be turned in with artwork)

By signing this agreement, the Artist agrees to place their field study and finished painting in the *Field to Finish* contest, exhibit and sale conducted by the Hoosier Salon New Harmony Gallery. The competition will be judged for **Best of Show \$500 (Donated by Dr. George and Peggy Rapp)**, and **five \$200 awards** in 2022 *First Brush of Spring* Paint Out (number of prizes may be adjusted if the entry fees do not cover the expense). If the art sells, the Salon will retain 40% and the artist will receive payment from the Hoosier Salon for 60% of the sale price.

The artist is required to pay a \$30.00 nonrefundable entry fee. The study must have been stamped at the 2021 FBOS. **The field study cannot exceed 12 inches unframed** and (18 inches in any one direction after framing). The final, finished artwork should not exceed 32 inches in any one direction (including frame). Both pieces must be framed, wired for hanging, and marked with the sale price. **Artwork must be for sale and delivered by April 4th, unless special arrangements are made.** Questions: Contact Linda Volz at [lvolz@hoosiersalon.org](mailto:lvolz@hoosiersalon.org)

The paintings will be hung at the discretion of the Gallery manager. Paintings will be displayed and for sale from April 7-May 22, 2022, in the New Harmony Hoosier Salon Gallery. Consigned works may be photographed as part of a virtual gallery and displayed on the Hoosier Salon web site. The artist is responsible for planning to pick up any unsold paintings at the end of the sale period. Normal precautions will be taken to safeguard the artwork. Hoosier Salon personnel will not be responsible for loss or damage. In the event of loss or damage, no more than 50% of the established retail value or \$2500, whichever is less, will be paid for the two items.
